- **BOATS MUST BE REMOVED FROM WINTER ISLAND BY MAY 15TH;**
- **BOATS NOT REMOVED BY MAY 15th WILL BE CONSIDERED ABANDONED AND AUCTIONED TO THE PUBLIC IN ACCORANCE WITH MGL CH 135 SECTION 8;**
- **THE BOAT OWNER VOLUNTARILY ASSUMES ALL RISK OF PROPERTY LOSS AND PERSONAL INJURY AND WAIVES ALL RIGHTS OF ANY NATURE AGAINST THE CITY OF SALEM, ITS EMPLOYEES, SUB-CONTRACTORS AND AGENTS; and**
- **BOAT OWNER MUST ABIDE BY TERMS AND CONDITIONS ATTACHED HERETO.**

WINTER ISLAND BOAT STORAGE TERMS AND CONDITIONS

1. Boats stored at Winter Island are arranged to maximize use of available space. Therefore, once a boat is stored for the off-season, it may not be moved out prior to the end of the storage period without the approval of the Harbor Master or his designee.
2. The Boat Storage season at Winter Island begins September 1st each year and concludes May 15 of the following year.
3. All boats and trailers shall be removed no later than May 15th each year unless prior arrangements have been made for the continued storage with the City's Harbormaster.
4. Arrangements to move boats and trailers must be made with the office of the City Harbormaster.
5. If a boat and trailer remains unclaimed for one month, on or about June 15th, the owner shall receive notice by registered mail of the city's intent to take possession of the boat and trailer. If the owner of said property refuses or fails for a period of ten days following said receipt to remove the property, the city may sell the property, excepting money unclaimed, by public auction, notice of the time and place of sale, with a description of the property to be sold, first being given by publishing the same once in each of three successive weeks in a newspaper published in such city.
6. Before any or boat may be stored at Winter Island, the owner must have paid all current City of Salem excise tax and mooring fees relative to the boat and trailer. Failure to remain current with excise taxes and mooring fees will result in the owner not being allowed to store his or her boat on City property.
7. The City, its agents, officers and employees assume no responsibility for any boat or trailer stored at Winter Island and will not be responsible for any damage to a boat or trailer or equipment on the boat including, but not limited to, fire, theft, vandalism, freezing and storms.
8. The owner may not perform maintenance on the boat or trailer while stored at Winter Island.
9. The owner must conduct him or herself at all times when at Winter Island so as not to create any annoyance, hazard, or nuisance to other boaters or visitors.
10. Each owner must clean up and remove any debris or other material when the boat is taken out of storage in the Spring. Failure to adequately clean up any refuse will be a cause for denying the right to store a boat in the future.
11. The owner agrees to indemnify and hold harmless the City, its agents, and employees from and against any liability, damages, losses, claims, demands, and expenses what so ever, including attorneys fees which may arise directly or indirectly from storage of the boat and trailer at Winter Island.
12. In the event that the owner shall sell or otherwise transfer the boat and or trailer, while it is stored at Winter Island, the owner shall immediately notify the Harbormaster in writing.
13. These terms and conditions shall be binding upon and to the benefit of the heirs, executors, administrators, and assigns of the owner.
