SPECIAL ALCOHOLIC BEVERAGES LICENSE - MGL CHAPTER 138-14

Special Licenses to Managers of indoor and outdoor activities.

1. A Special Alcoholic Beverage License is required from the Licensing Board for any activity at which alcoholic beverages are served.
2. A License may be issued to the responsible Manager of any indoor or outdoor activity or enterprise for wine and malt beverages only.
3. A License may be issued to the responsible Manager of any non-profit organization conducting any indoor or outdoor activity for all alcoholic beverages or wine and malt only.
4. All alcoholic beverage laws shall be observed.
 - a. MGL Chapter 138-34, Sale or delivery or furnishing alcoholic beverages to persons under twenty-one (21).
 - b. MGL Chapter 138-69, Sale or delivery to intoxicated persons.
 - c. City Ordinance Section 24-19, Drinking alcoholic beverages on public ways or public places.
5. Conditions of Special License
 - a. A Police Officer shall be required at all activities in which alcoholic beverages are served. This is to insure that all laws are being observed and to provide for the safety of all in attendance.
 - b. It shall be the responsibility of the server not the Police Officer to identify under age guests attempting to obtain alcoholic beverages.
