In the year Two Thousand and Seventeen

An Ordinance to amend an Ordinance relative to prohibiting dogs in historic cemeteries

Section I. Article I of Chapter 16 – Cemeteries is hereby amended by inserting a new section as follows:

JULY 20, 2017

"Sec. 16-6. – Dogs prohibited from certain historic cemeteries.

- (a) Dogs, excluding service dogs leashed and in control of the owner, are prohibited in the Broad, Charter, Howard and Essex Street cemeteries.
- (b) Any person violating this section shall be punished by a fine not exceeding \$50.00.
- (c) The Director of Public Services or his/her designee, the Inspector of Animals or a police officer may enforce this section."

Section II. This Ordinance shall take effect as provided by City Charter.

#461 - (#397) ORDINANCE FOR THE RIGHTS & TREATMENT OF DOMESTICATED ANIMALS

- 6. A veterinarian, animal trainer or individual whose work focuses on the care of animals and who shall be designated by the other six members of the Working Group.
