**SPECIAL MEETING OF THE CITY COUNCIL**

A Special Meeting of the City Council held in City Council Chambers on Monday, July 31, 2017 at 6:30 P.M. for the purpose of taking action of the following matters:

- Order for the relocation of a polling location for Ward 2 to St. Peter's Episcopal Church Hall,
- Order for the City Preliminary Election on September 12, 2017
- Order extending a trial period for one-way traffic on Endicott and Prescott Streets
- Ordinance Traffic repealing Special Speed Regulations on Swampscott Road
- Ordinance amending Ch. 22 – Noise Ordinance by adding Sec. 22-6 Excessive Noise from Compression Brakes Prohibited
- Committee report for an Ordinance amending Traffic Handicap Parking on Naples Road.

Councillor McCarthy was recorded as absent.

Council President Elaine F. Milo presided.

**#482 – RELOCATION OF A POLLING LOCATION FOR WARD TWO (2)**

Councillor Famico introduced the following Order, which was adopted by a roll call vote of 10 yeas, 0 nays, 1 absent. Councillors Turiel, Sargent, Ryan, Lovely, Gerard, Furey, Famico, Eppley, Dibble and Milo were recorded as voting in the affirmative. Councillor McCarthy was recorded as absent.

ORDERED: that the polling location for Ward 2 Precinct 1 and Ward 2 Precinct 2 be relocated from St. John's School Hall to St. Peter's Episcopal Church Hall, 24 St. Peter Street.

A motion for immediate reconsideration in the hopes it does not prevail was denied.

**#483 – ELECTION ORDER FOR CITY PRELIMINARY ELECTION**

Councillor Furey introduced the following Order, which was adopted.

ORDERED: that the meetings of the qualified voters of the City of Salem be held in all precincts in the city at the polling places designated hereinafter on Tuesday, September 12, 2017 for the purpose of casting votes in the City Preliminary Election for the nomination of candidates for the following offices:

**Councillor-At-Large:** for the term of two (2) years

**Councillor of Ward Two:** for the term of two (2) years

And be it further ordered that the polls at said meetings be opened at 7:00 AM and closed at 8:00 PM and that the City Clerk be instructed to post this notice as required by law.

**#484 – ORDER FOR EXTENTION OF A TRIAL PERIOD ON ENDICOTT ST AND PRESCOTT STREET**

Councillor Lovely introduced the following Order, which was adopted.

ORDERED: that the trial period be extended another sixty (60) days for the following traffic recommendations:

Endicott Street, One Way, eastbound from Summer Street to Margin Street

Prescott Street, One way, eastbound from Summer Street to Margin Street

**#485 – ORDINANCE TRAFFIC, SPECIAL SPEED REGULATIONS**

Councillor Lovely introduced the following Order, which was adopted for first passage.

In the year two thousand and seventeen

An Ordinance to amend an Ordinance relative to Traffic

Be it ordained by the City Council of the City of Salem as follows:

Section 1. Chapter 42, Section 88 – Special Speed Regulations:

Repeal Swampscott Road eastbound, and beginning at a point 200 feet east of the junction of Highland Avenue, Route 107, thence easterly 0.30 miles at 35 miles per

hour, 0.80 miles at 40 miles per hour, 0.310 miles at 30 miles per hour, ending at the Salem/Swampscott line; the total distance being 1.20 miles.

Section 2. Repeal Swampscott Road – westbound, beginning at a Swampscott/Salem line, thence westerly 0.10 miles at 30 miles per hour, 0.80 miles at 40 miles per hour, 0.30 miles at 35 miles per hour, 0.04 miles at 25 miles per hour, ending at the junction of Route 107, Highland Avenue, the total distance being 1.24 miles.

Section 3. This Ordinance shall take effect as provided by City Charter

**#486 – ORDINANCE AMENDING CH. 22, NOISE CONTROL**

Councillor Lovely introduced the following Order, which was adopted for first passage.

An Ordinance to amend an Ordinance relative to Noise Control

Be it ordained by the City Council of the City of Salem as follows:

Section 1. Chapter 22 – Noise Control, Article I. In General, by adding Section 22-6 – Excessive Noise from Compression Brakes Prohibited.

**#487 – COMMITTEE REPORT - ORDINANCE, TRAFFIC HANDICAP PARKING NAPLES ROAD**

Councillor Ryan offered the following report for the Committee on Ordinances, Licenses and Legal Affairs. It was voted to accept the report and adopt the recommendation.
