It wasn't all surveys. There were meetings, (focus groups), and some were notes and seeing what topics came up. This wrapped up in the summer. It started in the winter. It became clear that the organization did not want to do all senior center assessment. It was one page, not very descriptive. Abby encourage them to put some things on the survey - demographic information and if the participants were living in senior housing but the JC&FO was not searching for in depth information on seniors. Per Abby, the report was board but not deep.

Conclusion: We need to look at that report.

Department status and outlook for the year is looking forward and in the right direction.
 Everyone is looking forward to the new Community Life Center.
 The programs have come a long way from last year to this year.
 Reorganization of the department has been helpful. There is more focus. The program manager came on board then the COA Director left. There is good rapport with the North Shore Elder Services. The staff's moral is up. The outlook is positive and team driven. We are offering more for the seniors. There are more rides than in the past about 200 to 300 more rides a month, same people more rides. More people are recognizing the COA. The COA is mentioned in the monthly newsletter that covers both Park and Recreation and COA Seniors.
