A meeting of the Licensing Board was held on February 16, 2022 at 6 p.m. In attendance were: Chairman Gary Barrett and members Deborah Greel and Gary Santo, Jr., City Solicitor Beth Rennard, Special Investigator, Mike Ball and Clerk of the Board Melissa Pagliaro.

LICENSING BOARD MEETING MINUTES - DRAFT

- 1. Application for a One Day Liquor License on May 21, 2022 for a Wedding for 130 people from 5-10p.m. at Hamilton Hall. Applicant: Hayley Hannan and Jacob Doue.
 - Robin Perry presented the application and said some events are coming up that were rescheduled from 2020. She said the alcohol will be purchased from Kappy's as allowed and be served by Vinwood. Ms. Pagliaro said that all paperwork is in order. Ms. Greel motioned to approve. Mr. Santo seconded. Mr. Barrett said all are in favor and motion carries. Roll call vote 3-0.
- 2. Application for a One Day Liquor License on March 12, 2022 for a Concert/Art Installation for 50 people from 6-9 p.m. at Old Town Hall/Derby Square. Applicant: Notch Brewing.
 - Rob Hughes presented the application. He said they will be stationed on the first floor of Old Town Hall for the event. Sgt. Ball asked if they had a detail in place. Rob said he talked to Officer Gagnon. Sgt. Ball said he would need to speak to Office White and also contact fire for a detail. Rob said it could be between 50 and 100 people. Ms. Pagliaro suggest they amend the application for up to 100 people. Ms. Greel motioned to approve and amend for up to 100 people. Mr. Santo seconded. Mr. Barrett said all are in favor and motion carries. Roll call vote 3-0.
- 3. Application for a One Day Liquor License on June 25, 2022 for the Annual Pride Parade and Festival for 10,000 people from 11 a.m.-5 p.m. on the Salem Common. Applicant: Hope Watt-Bucci and North Shore Pride.
 - Hope said she lives at 2 Putnam Ct in Manchester by the Sea and presented the application. She said Notch and Deacon Giles will be serving their product for this year's event and entertainment will go from 1-5 p.m. She said they are looking to have over one hundred vendors including some food trucks. Ms. Greel asked if anyone check with DPS regarding workers for event. Ms. Rennard said she would check. Hope said she has been to Park & Rec. Ms. Rennard said they'll need to submit a Certificate of Insurance. Ms. Greel motioned to approve pending Insurance. Mr. Santo seconded. Mr. Barrett said all are in favor and motion carries. Roll call vote 3-0.
- 4. Application for a One Day Liquor License on March 24, 2022 for the Film Festival Live Event/Open Night Reception for 75 people from 6-7 p.m. at 35 Congress St. Applicant: Salem Film Fest. No one appeared. Move to next meeting March 14, 2022 and notify applicant.
- 5. Application for two sub licensees at Pentagram, 282R Derby Street. Applicants: Alicia Santello and Nathan King.
 - Tim Regan, 5 Orange St., owner presented the applications. He also explained to the Board that he is within his limit of readers as some that have been advertised are under his store but are not

physically in the store. He said he also keep a separate log book for them to show their work. They only read from their homes out of state over the phone. Ms. Rennard said that is ok and we do not license those that read over the phone. Mr. Santo motioned to approve pending CORI checks. Ms. Greel seconded. Mr. Barrett said all are in favor and motion carries. Roll call vote 3-0.

6. Application for a Change of Manager at Bit Bar, 278 Derby Street. Applicant: Maxwell Clark.

Max Clark and Gidon Coltof, owner presented the application. Max said he has been managing restaurants for 13 years and working in them for 15 years. He said he has been at Bit Bar since 2016. Ms. Pagliaro said all the paperwork is in order. Ms. Greel motioned to approve. Mr. Santo seconded. Mr. Barrett said all are in favor and motion carries. Roll call vote 3-0.

7. Application for Change of Manager at Steve's Quality Market, 36 Margin Street. Applicant: Ann Ingemi Kapoll.

Anne from 7 Tufts St. Marblehead presented the application and said this is a simple change of manager application. Ms. Pagliaro said all the paperwork is in order. Mr. Santo motioned to approve. Ms. Greel seconded. Mr. Barrett said all are in favor and motion carries. Roll call vote 3-0.

8. Application for a Transfer of an Annual Wine & Malt Liquor License at 71 Lafayette Street. Applicant: d/b/a Engine House Pizza.

Attorney Chad Colarusso presented the application. He said that K&M Hurley, Inc which is owned by Scott Hurley is purchasing the business. Scott Hurley of 28 Sherman St. Peabody said he has owned Deli House on Congress St. for 13 year and is excited about taking over Engine House. He said it holds a basic beer & wine license and he is going to keep running it as is. Mr. Santo motioned to approve. Ms. Greel seconded. Mr. Barrett said all are in favor and motion carries. Roll call vote 3-0.

9. Application for a Class II Auto Dealers License at 51R Canal Street, continued from January 10, 2022 meeting

Ms. Pagliaro shared the map of the area with the Board and public. She said she has been by the property and the map is accurate. Sgt. Ball also said he knows the area. Mr. Barrett said it appears that the drawing is good and the applicant has done as asked and he would accept a motion. Mr. Santo motioned to approve with the spaces being kept lined and three cars for sale and two for customer parking. Ms. Greel seconded. Mr. Barrett said all are in favor and motion carries. Roll call vote 3-0.

10. Application to amend an Entertainment License to add a Jukebox. Applicant: All Souls Restaurant, 282 Derby Street.

Applicant was not present but Ms. Greel said she's been there and assumes he's using it only for background music. Mr. Barrett said he will accept a motion but the owner owed the Board the courtesy of appearing. Ms. Greel motioned to approve. Mr. Santo seconded. Mr. Barrett said all are in favor and motion carries. Roll call vote 3-0.

11. Approval of Meeting Minutes from December 27, 2021, January 10 & 24, 2022. Mr. Barret thanked Mr. Santo for reviewing. Ms. Greel motioned to approve. Mr. Santo seconded. Mr. Barrett said all are in favor and motion carries. Roll call vote 3-0.

- Ms. Pagliaro informed members that the Matrix on "How to" for alcohol licenses is online.
- Ms. Greel requested that the Street Performer issues of time, place and manner be places on an Agenda for March or April for a discussion.
- 13. Adjournment: 6:53 p.m. Mr. Santo motioned to approve. Ms. Greel seconded. Mr. Barrett said all are in favor and motion carries. Roll call vote 3-0.
