MEETING MINUTES – DRAFT

A meeting of the Licensing Board was held on July 11, 2022 at 6:00 p.m. In attendance were Chairman Gary Barrett and members Deborah Greel and Gary Santo, Jr., Melissa Mojica, Clerk of the Board and Special Investigator, Mike Ball.

1. Application for a One Day Liquor License for Friends of the Salem Council on Aging on July 14, 2022 for 75 people for a fundraiser at Winter Island Pavilion from 5-7:30 pm. Applicant: NS Bartending.

Ms. Greel motioned to approve. Mr. Santo seconded. Mr. Barrett said motion the motion carries. Roll call vote 3-0.

2. Application for a One Day Liquor License for Allison Donine on August 13, 2022 for 100 people for a Wedding Reception at Old Town Hall from 5-10 pm.

Ms. Donine presented the application and said it is for her wedding reception. Ms. Greel asked if that was the capacity and who was serving. Ms. Donine said that it was up to 140 people and they have hired a serving company out of Boston to serve beer & wine. Ms. Greel motioned to approve. Mr. Santo seconded. Mr. Barrett said the motion carries. Roll call vote 3-0.

3. Application to amend the Entertainment License to include live outdoor music on Friday and Saturday nights from 8-11 pm. Applicant: Witch's Brew, 156 Derby St.

John Kounsaleih, co owner presented the application and said they are requesting that it only be for indoor now and not outside. He said they decided not to even try the karaoke. Mr. Santo asked if it would be acoustic. Mr. Kounsaleih said yes only acoustic. Ms. Mojica asked how many pieces. John said it would be one to three. Mr. Santo motioned to amend the indoor liquor license to add up to 3 piece live acoustic music on Friday and Saturdays from 8-11pm. Ms. Greel seconded. Mr. Barrett said the motion carries. Roll call vote 3-0.

4. Application for a Common Victuallers License and Entertainment License. Applicant: BRAZLYNN2, Inc. d/b/a Camilla's Café & Breakfast, 140 Canal Street.

Sergio Espinoza presented the application. He said the owners are husband and wife and are looking to open a breakfast restaurant at the old Honey Dew Donuts on Canal St. He said they also own a restaurant in Lynn. He said they would like to open at 4am and stay open until 9 but the business is mostly breakfast and lunch. Ms. Greel asked how many seats. Mr. Espinoza said about 22. Ms. Mojica said the Building Dept. will determine the capacity and that they will have to go before the City Council for the early open before 6am. Mr. Espinoza said they are looking to have the entertainment license approved also for televisions. Ms. Greel motioned to approve.

Mr. Santo seconded. Mr. Barrett said the motion carries. Roll call vote 3-0. approve pending CORIs, health department approval and City Clerk's approval for the early open.

5. Approval of Meeting minutes from May 23, 2022. Mr. Barret said he read them and they were fine. Ms. Greel motioned to approve. Mr. Santo seconded. Mr. Barrett said the motion carries. Roll call vote 3-0.
