Ladies and Gentlemen of the City Council:

Enclosed please find an Order granting two School Department employees exemption from Massachusetts General Law Chapter 268A, Section 20, so that they may accept part-time positions with the Department of Park, Recreation, and Community Service.

In order to accept these part-time positions, the Conflict of Interest Law requires that these employees meet certain conditions, they must certify that they will perform the duties outside of their normal work hours for the School, work less than 500 hours per year for the Department of Park, Recreation, and Community Service, and receive an exemption from Section 20 of the Conflict of Interest Law from the City Council.
