#40 - Accessibility of voters at the Salem polls on election day and all early voting efforts for the 2016 elections with particular attention paid to the elderly, voters with disabilities and voters with any language barriers

### **• City solicitor B. Rennard:**

- Spanish ballots - waiting for information from the state
- mail - from LLC → Resolution for the city council re-tied into council's role
- Board of Registrars - drafting an MoU
- voting responsibilities of council - support mission, supporting funding

- C. Eppley - Praise rates of poll workers + wardens 2) allow 1 hr. training  
3) attract translators (interpreters)
- \* Mayor - what we are paying poll workers - shouldn't be out of reach, practices can be improved, other communities we can improve
- Chief Butler - LLC has helped, approached officers + provided laws around issues & what is expected of them, Police deal with crimes and issues of impressions - will share document
- Chuck Barton - Board of Registrars - met to discuss roles + responsibilities, touching meeting off Mac. main duty - registering people to vote, recounts - discuss/decide on contested ballots
- David Martell, Princeton Crossings, Disabilities commission
  - visited polling places
  - St. Mary - Castle Hill - handicapped parking behind School
  - Witchcraft Heights - not a clear entrance, needs sign for voting
  - certified by state on surveys → know what to look for - ramps, spaces between tables etc.

- Resources - as a warden the <sup>wage!</sup> earnings were too low - an issue should add more \$ for wage + better training
- education - need to do more to educate about civics
  - How are we educating students & new citizens about civics?
- C. Sargent - his high school civics teachers would be appalled. maybe high school students could help?
  - Do we have procedures in place if someone needs ASL and one (translator) isn't available?
- C. Eppley - can CCA use vans to transport seniors to the polls?

C. Sargent - received October email. called board of registrars, spoke with city clerk. we are trying to get better, not go by the minimum.

C. Turkel - As of this year 10/11 councillors can be reached by city of Salem email system

### a) Jeff Cohen, 12 Hancock St. No Place for Hate

- city clerk has agreed to attend a No Place for Hate committee
- committee has a member of the police, LLC, city - soon to be a member from the schools
- communication - small city - can do better to diminish problems
- council overseeing elections - problematic because elected, and councillors don't necessarily mirror at large population
- electoral commission - may be a positive step, be representative of the city. Beyond election day, but year-long process - require more info/knowledge to community / communicate importance to community

- Jean Kempthorne Dearborn, Common Cause
  - Sec. Galvin has distributed draft guidelines about early voting → leaving to discretion of city/town clerks
  - common cause - urging cities w/ more than 35,000 to add 1 more voting location + add weekend + evening hours → common cause willing to work with cities + towns + to reallocate funds + allocate funds

- C. Eppley - Florida has early voting & has weekend + evening hours. Not anything new
- Jean - wants to move forward w/ resources
- C. Eppley - Common Cause is suggesting Salem has 2 early voting locations
- mayor - would Council have a task force? Voting locations + early voting efforts? - Do it collectively together, better budgeting
- C. Eppley - can have a task force for early voting & resolution
- C. Famico - could a new order be required?
- city solicitor - could request a task force

## ○ Russ Grand - 97 Freedom Mall

- appears to only be a Latino Population issue - Salem is a patchwork city → discriminatory issue → can't focus on just one language issue
- C. Famico - certain group reached up to us, high% of population, what is written is always a snippet of what is said - up to writer ALSO - affects many different groups
- C. Turiel - depends on the city's % of what language, need to get more people to vote - want to get # of people engaged up.
- C. Ryan - kids in the schools - schools info - in English + Spanish.
- Russ - people issue -
- C. Ryan - we need to make it so everyone can vote
- C. Famico - schools send info + multiple languages
- C. Sargent - can have steps taken for everyone

- issues came from redistricting → change of voting location  
caused confusion

- Russ - MCM, if you have laws in place, then the laws nullify the MCM. If there is something not covered by law, then draft an MOU — use laws that you have to act on problems w/ staff, departments, etc.

- C. Sargent - at elections / (inauguration) swear by state + federal laws

- Repulsed by some of what he heard - voting rights issue brought by LLC - exercised constitutional rights to bring an issue forward

• Chuck Barton, Board of Registrars

- below expectations of 21<sup>st</sup> century - technology can help with the process → do not block out technology when moving forward

- C. Sargent → at voting location, have list of streets per precinct  
- C. Turiel → can do a lot quickly moving forward

• Ana Nuncio, Winter St.

- MCM needed as Latino community singled out → lawyer who is a member of LLC helped unite → civil rights were violated → MCM a tool became necessary → attempts to bring to level of equality.

• Russ Grand, 97 Freedom Hall

- police at polls → city council needs to send a message - play by the laws

- Title 42, 1975, deprivation by color of law — consequences to the people who do it

• Mayor - when we discussed the MCLL, (lawyer or LLC), we aren't a committee that only depends on laws as our standards - (cited antidiscrimination) be more proactive, equity + education - all have ability to succeed + communicate w/ local government - acknowledge fault/st be better at addressing - break down barriers + create equal access
