C. Dibble referred to conversation about tactics

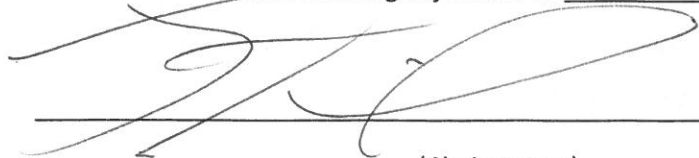
C. Lovely thanks Mickey for conversation, agrees on goal of expanding access to non-white, non-native citizens
