#### <u>#231 – HOME RULE PETITION FOR POLICE OFFICER BRIAN BENSON RELATIVE TO</u> <u>RETIREMENT</u>

The following Order introduced by the Mayor was adopted by a roll call vote of 10 yeas, 0 nays and 1 absent. Councillors Turiel, Sargent, Peterson, Milo, McCarthy, Madore, Furey, Flynn, Dominguez and Dibble were recorded as voting in the affirmative.

ORDERED: That a petition to the General Court, accompanied by a bill authorizing the Salem retirement board to retire Brian Benson as set forth below, be filed with an attested copy of this Order be, and hereby is, approved under Clause (1) of Section 8 of Article 2, as amended, of the Amendments to the Constitution of the Commonwealth of Massachusetts, to the end that the following legislation be adopted, except for amendments by the Senate or House of Representatives which conform to intent of this home rule petition:

AN ACT AUTHORIZING THE RETIREMENT BOARD OF THE CITY OF SALEM TO RETIRE BRIAN BENSON, A POLICE OFFICER OF THE CITY OF SALEM

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same as follows:

SECTION 1. (a) Notwithstanding any general or special law to the contrary, the Salem retirement board shall retire Brian Benson, a police officer of the city of Salem, who as a result of injuries sustained while in the performance of his duties in October, 2014, is totally and permanently incapacitated from performing the essential duties of a police officer.

(b) The annual amount of pension payable to Brian Benson shall be equal to the regular rate of compensation which would have been paid had he continued in service as a police officer of the city of Salem at the grade held by him at the time of his retirement until his death or reaching mandatory retirement age whichever comes first. The additional benefits granted in this act shall be funded and administered by the Salem retirement board, consistent with and subject to chapter 32 of the General Laws, except sections 8 and said 91A of said chapter 32 shall not apply. All amounts paid under this act shall be non-taxable. (c) Upon attaining the mandatory retirement age for a police officer in the city of Salem, Brian Benson shall receive a pension pursuant to section 7 of said chapter 32, a yearly amount of pension equal to 80 per cent of the annual rate of the compensation he was receiving on the day before he reaches the mandatory retirement age for a police officer in the city of Salem.

SECTION 2. Brian Benson shall be entitled to receive indemnification for all hospital, medical and related expenses that have been or may be incurred after the date of his retirement as a result of the injuries sustained by him while in the performance of his duties in October, 2014, in accordance with sections 100 and 100B of chapter 41 of the General Laws.

SECTION 3. In addition to the benefits granted herein and upon retirement, Brian Benson shall receive a lump sum from the Salem retirement board equal to his total accumulated retirement deductions.

SECTION 4. If Brian Benson is married at the time of retirement, then upon his death, should his wife, Shannon, survive him, the Salem retirement board shall pay to her an annuity in the amount of 75 per cent of the amount of the pension which otherwise would have been payable to him until her death. The pension shall be subject to section 103 of chapter 32.

SECTION 5. In the event that both Brian Benson and his wife, Shannon, die before their children reach the age of 18 or 22, as provided in this act, the payments that would otherwise have been made to Shannon shall be payable, in equal shares, to each surviving child under the age of 18; provided, however, that payments shall continue for the benefit of a surviving child 18 years or older who, on or before the date of death of Shannon or Brian, whichever is later, had been medically determined to be permanently physically or mentally incapacitated from earning or for the benefit of a child under the age of 22 who is enrolled as a full-time student.

SECTION 6. This act shall take effect upon its passage.

Councillor McCarthy requested and received unanimous consent for suspension of the rules to allow Mr. Benson to speak.

WHEREAS: His death has taken from our Community not just only a prominent business man, but a compassionate, kind, gentle and caring soul who demonstrated these virtues to other families in their most difficult and challenging times; and

WHEREAS: Salem values its rich family traditions and legacies like the O'Donnell Family. Tom worked in the family business, Henry J. O'Donnell & Sons and took the reins at the age of 28 and became the third generation to help the residents of Salem and the North Shore in their time of need and comfort; and who passed his living legacy of compassion and service to humanity onto his only son Anthony in 2013; and

WHEREAS: Tom will always be remembered for greeting friends and family with "Top of the Morning" with his sparkling eyes, wide grin and hearty laugh. His Priest said "Heaven is a kinder place with Tom in it." His brother Henry "Hank" O'Donnell also paid homage to his brother from a quote by Ted Kennedy "Our work begins anew, hope rises again and the dream will never die"; and

WHEREAS: Tom lived and loved every 76 years of his life. Thomas O'Donnell was much more than a Funeral Director. He attended St. Mary's Grammar School, he enjoyed his summers and weekends on the Common as a member of the Drum and Bugle Corps. He attended Salem High School and played Varsity Football and was a 1960 graduate. Tom continued his education at the Main Maritime Academy receiving a Bachelor's degree in Engineering in 1964. Shortly after, he began working for Texaco Oil Company as a Junior Engineer and as he travelled and saw the world from the bottom of the engine room he rose to the top and became Texaco's Chief Engineer. In 1969, Tom came home, back to his roots, to help his family; and

WHEREAS: Tom O'Donnell also was one to give back to his city and his community. Tom was a member of the Salem Common Neighborhood Association, the Salem Rotary Club, the Knights of Columbus, the Salem-Beverly Elks Lodge and the Aleppo Shrine Temple to name a few. He was always there to help and always with a smile; and

WHEREAS: Tom has earned the respect, admiration and high regard of all whom he came into contact with and all of those he helped, and this community has sustained a great loss in his death; and

NOW, THEREFORE, RESOLVED that the Salem City Council on behalf of all our citizens hereby extends to the members of his family and those he loved our sincere condolences in this time of their bereavement; and

#### **#239 – RESOLUTION – GREEN NEW DEAL**

The following Resolution introduced by Councillor Peterson was adopted as amended

#### Original Submission:

Resolution:

WHEREAS: Shortly after the 2018 midterm elections, there was a groundswell of grassroots support for a proposal from then Rep-elect Alexandria Ocasio-Cortez, to create a "House Select Committee on a Green New Deal" and she and Massachusetts Senator Ed Markey are leading the efforts in the Congress; and

WHEREAS: Such a Green New Deal would address the climate crisis at the scale of intervention called for by the recent IPCC special report on climate change<sup>1</sup>, a report that was ultimately rejected by the US government and other oil exporting countries at COP 24 in Poland (US pulling out of the Paris Accords); and

WHEREAS: Such a Green New Deal would also create many new jobs for hard working Americans who have been left behind by globalization and automation; and

WHEREAS: Grassroots advocacy groups have organized more than 250 visits to district offices around the country around this issue in just over a month's time, winning the support of more than 60 members of congress including Salem's House delegation member Seth Moulton; and

WHEREAS: The City of Salem is already taking action to reduce its carbon emissions and promote clean energy, including implementing PowerChoice, which we have had in effect for over four years, bringing 100% green energy options to all residents and businesses, encouraging alternative transportation through increased bicycling and feasibility of a Citywide shuttle, installing electric vehicle charging stations, pursuing renewable energy generation projects to rely less on conventional utilities for power, continuing to implement energy efficiency and conservation strategies in buildings and operations in accordance with the City's participation in the Mass DOER Green Communities program; and

WHEREAS: The City of Salem has already completed a Climate Change Vulnerability Assessment and Adaptation Plan in 2014, recognizing the threat of climate change to Salem's infrastructure and natural resources, The City has already begun addressing these vulnerabilities using MA Office of Coastal Zone Management resources to assess green infrastructure adaptation strategies including zero net energy, flood control management and beginning to update the City's emergency management plan to reflect rising sea levels and storm surges for major events; and

WHEREAS: The City of Salem was the first community in MA to pass a 100% clean energy resolution in 2014 and passed a resolution in 2018 to encourage our state legislators to pass legislation to institute carbon pricing and a comprehensive omnibus energy bill that addresses the wide range of initiatives such as mitigating gas leaks, net metering and increasing the state's portfolio of renewable energy sources such as wind and solar; and

WHEREAS: It is imperative that Congress address the climate crisis with the urgency that is required to avoid the worst consequences of climate change including extreme heat, drought, fires, flooding, natural disasters, and poverty; and

WHEREAS: The United States is indeed already experiencing these impacts, from devastating hurricanes in Puerto Rico, North Carolina & Texas to the "Camp" wildfire in California that demolished an entire town, Salem is experiencing the recognized consequences of being a coastal community, in particular coastal flooding and sea level rise that is already being realized; now therefore be it

RESOLVED: That the Salem City Council go on record in full support of a Green New Deal that includes both a rapid shift away from fossil fuels and creating jobs for American workers in renewable energy and associated industries; and be it further

RESOLVED: That the Salem City Council go on record urging our Congressional Delegation to continue advocating for such a Green New Deal and to make addressing the climate crisis a top priority in 2019 and beyond; and be it further

RESOLVED: That all relevant Council Subcommittees and City Boards & Commissions work together to achieve the maximum resiliency and sustainability possible: and be it further

RESOLVED: That the City Clerk hereby will forward suitably engrossed copies of this resolution to Rep. Seth Moulton and on behalf of the entire Salem City Council.

Councillor Peterson, as liaison to SERC, stated as a coastal community expensive repairs to piers and gas leaks. We want to lay the ground work to urge delegation to work hard on this and the Council is behind this and supports this.

Councillor Milo not opposed to anything – Salem is doing a great job at addressing climate change. However, would like to see this go to committee and educated and maybe amend some of the language. We need assistance at the State and Federal levels.

Councillor Furey opposed to sending this to committee. We shouldn't micro manage and dissect each word. We need to send a clear message something should be done. Sends a wrong message if we send it to Committee.

Councillor Peterson said the first step is laying the foundation. The SERC committee did intense work on this and she is comfortable sending this on as is.

Councillor McCarthy stated we all agree with rising tides and flooding he agrees with everything but the first four (4) paragraphs; the should be deleted and start the resolution with the fifth paragraph. The first four paragraphs are referring to more political issues instead of doing as much as we can on a local level as a coastal community.

Councillor Sargent agrees with Councillor McCarthy that the first four paragraphs should be deleted but he is also opposed to using the words "Green New Deal" because this is only an idea right now. We would be voting on something before the fact. Congress is still working on the deal. Shouldn't support something we can't read yet. Suggests we use green initiatives not the word deal.

Councillor Furey assumes Chair.

Councillor Dibble concurs with Councillor Sargent relative to deleting the first 4 paragraph and changing the word to initiative. This deal has not been crafted yet can't support it when there is nothing in writing. We need to get this done but like to see it go to committee.

Councillor McCarthy made a motion to remove the first four (4) paragraphs. Councillor Turiel seconded it. It was so voted.

Councillor Sargent made a motion to remove and replace Green New Deal with green initiative. Councillor Flynn seconded motion.

Councillor Milo asked Councillor Peterson why wouldn't green initiative serve the same purpose. Why is it so important to have Green New Deal?

Councillor Peterson responded it is important. This is serious to carry weight this isn't about putting in initiative but real weight.

On Councillor Sargent's motion to remove and replace Green New Deal with green initiative received a 5 in favor 5 opposed. The matter does not carry.

On Councillor Peterson's motion to replace uppercase to lower case received 7 in favor, 3 present. The motion carries.

Councillor Milo asked that a friendly amendment to add our State Delegation. It was voted

Councillor Peterson Moved for adoption as amended. The matter carries. Councillor Flynn was recorded as opposed and Councillor Sargent was recorded as present.

#### RESOLUTION

WHEREAS: The City of Salem is already taking action to reduce its carbon emissions and promote clean energy, including implementing PowerChoice, which we have had in effect for over four years, bringing 100% green energy options to all residents and businesses, encouraging alternative transportation through increased bicycling and feasibility of a Citywide shuttle, installing electric vehicle charging stations, pursuing renewable energy generation projects to rely less on conventional utilities for power, continuing to implement energy efficiency and conservation strategies in buildings and operations in accordance with the City's participation in the Mass DOER Green Communities program; and

WHEREAS: The City of Salem has already completed a Climate Change Vulnerability Assessment and Adaptation Plan in 2014, recognizing the threat of climate change to Salem's infrastructure and natural resources, The City has already begun addressing these vulnerabilities using MA Office of Coastal Zone Management resources to assess green infrastructure adaptation strategies including zero net energy, flood control management and beginning to update the City's emergency management plan to reflect rising sea levels and storm surges for major events; and
