

**SPECIAL MEETING OF THE CITY COUNCIL**

- 2) Order that the sum of Seventy Thousand Dollars (\$70,000.00) is hereby appropriated within the "Sale of Property" account to be expended for the upgrades to the Mayor Jean Levesque Community Life Center.
