FACILITY DESCRIPTION:

Olde Salem Greens (OSG) is a 9 hole municipal golf course in Salem MA. It was built in 1933 and designed by the well-known golf course architect Wayne Stiles. The original name of the golf course was "Salem Municipal Golf Course" and is featured in the book "The Life & work of Wayne Stiles". OSG is one of the last 4 golf courses designed by Stiles & Van Kleek and shows many of the Stiles design characteristics, including elevated tee areas, generous landing areas and raised greens with heavy bunkering, mounding and false fronts.

All maintenance performed by the grounds crew is geared towards recovering all the original design aspects that have been lost over time. The majority of golf course equipment has been newly purchased within the past 10 years and, we are well equipped to perform golf course maintenance at a high level.

DUTIES:

This position will work with the Superintendent and staff performing all aspects of maintenance and repairs relative to a municipal golf course.

Responsible for overall routine/scheduled/emergency maintenance and repair of Golf Course equipment including but not limited to:

• Fairway mowers, greens mowers, tee mowers, rough mowers, utility vehicles, dump truck, reel grinding, and other small landscape equipment.

Position is responsible for mowing, course set up, watering, snow removal, and tree/brush maintenance. Other duties as assigned.

QUALIFICATIONS:

Valid MA Driver's License.

Demonstrable experience in equipment maintenance and repair required. Demonstrable experience in small engine/landscape equipment maintenance and repair required. Working knowledge of landscaping and/or golf course maintenance preferred.
