MEETING MINUTES

A meeting of the Salem Licensing Board was held on Monday, **March 28, 2016** at 6:45 p.m., at City Hall, 120 Washington Street in the third floor meeting room. In attendance: Bob St. Pierre, Chairman; Member Rick Lee; Special Investigator Sgt. Dennis Gaudet; Elizabeth Rennard, City Solicitor and Joanne Roomey filling in for Melissa Pagliaro, Clerk of the Board. Absent was Member Paul Flores.

AGENDA

1. **Application for various Street Performer Licenses. Applicants: Gwendolyn McCormick, Chris Fritz-Grice, Michael Kelly and Glenn French.**

All of the applicants, except McCormick were present. Chris Fritz-Grice, Michael Kelly and Glenn French were approved. Rick Lee reviewed all of the rules and regulations. Sgt. Gaudet spoke about the noise level. All applicants said they read the rules and regulations and signed them.

Mr. Lee motioned to approve. Chairman St. Pierre seconded. Motion carried.

2. **Application for a One Day Liquor License on 8/10/16 from 4:00 p.m. to 8:00 p.m. for Witches Cup at Salem Common. Applicant: Dan Shuman.**

Dan Shuman and an associate appeared and informed the Board that they would like to have a beer tent at the Common during the bike race, as they have for many years. He told the Board he would follow the procedures established previously, limiting drink tickets, having a police detail and controlling the entrance.

Maryann Curtin, a Common neighborhood resident, voiced her objection because she does not approve of alcohol on the Common. Chairman St. Pierre noted her objection.
