### **LICENSING BOARD MEETING AGENDA**

A meeting of the Salem Licensing Board was held on Tuesday, October 10, 2017 at 5:00 p.m., at City Hall Annex, 120 Washington Street in the third-floor meeting room. In attendance: Chairman Bob St. Pierre, member Paul Flores, Acting Clerk of the Board, Joanne M. Roomey, Special Investigator, Sgt. Doyle and City Solicitor Elizabeth Rennard. Absent was Clerk of the Board, Melissa Pagliaro.

1. Continued from last meeting - Application for a Transfer of an Annual Wine & Malt License at 293 Jefferson Ave, currently OKEA, Applicant: Queen Gourmet, Inc.

Applicant requested a continuance to the next meeting.

Chairman St. Pierre stated he would accept a motion to continue to next meeting. Mr. Flores said so moved. The matter was continued.

2. Continued from last meeting - Application to change the Pledge of a Liquor License. Applicant: The Ledger, 125 Washington Street; Attorney Adam Barnosky.

Brett Danny presented the application to change the Pledge. All paperwork was in order. Chairman St. Pierre said he will accept a motion to approve. Mr. Flores said so moved. The license was approved.

3. Application for two (2) One Day Liquor Licenses on 10/28/17 and 10/29/17 for Pre-Halloween weekend for 40 people on 10/28/17 from 12:00 p.m. to 11:00 p.m. and on 10/29/17 from 12:00 p.m. to 10:00 p.m. both at Far From the Tree Cider, 108 Jackson Street (Parking Lot). Applicant: Jen Tran.

Jen Tran presented the applications. She said they have additional security crew, wrist bands and got two portable toilets. The City Solicitor reminded Ms. Tran that the tent has to be separate and apart from their other licensed premises. All paperwork was in order. Chairman St. Pierre said he will accept a motion to approve. Mr. Flores said so moved. The licenses were approved.

4. Application for One Day Liquor License on 11/4/17 for a wedding at Salem Old Town Hall for 100 people from 5:30 p.m. to 10:30 p.m. Applicant: Joanna Balsamo and William Robinson.

Mr. Robinson presented the application. Chairman St. Pierre asked if he got a certificate of insurance and Mr. Robinson said yes. Sgt. Doyle asked if they got a police detail and Mr. Robinson did. All paperwork was in order. Chairman St. Pierre said he will accept a motion to approve. Mr. Flores said so moved. The license was approved.

5. Application for One Day Liquor License on 10/21/17 for a Run, Yoga and Beer Tasting at Yoga Sakti, 29 Bridge Street for 40 people from 5:15 p.m. to 7:30 p.m. Applicant: Yoga Sakti.

Khristin Bucci presented the application. Ms. Bucci stated they are doing a 5K run, yoga and beer tasting. Solicitor Rennard asked if they got a permit for 5k run and Ms. Bucci said yes. All paperwork was in order. Chairman St. Pierre said he will accept a motion to approve. Mr. Flores said so moved. The license was approved.

Ms. Davis explained that she is doing angel card readings, spirit reading, oracle reading and tarot readings. Chairman St. Pierre asked her if she was aware of the Ordinance and she said she was.
