MEETING MINUTES

A meeting of the Salem Licensing Board was held on Monday, **December 18, 2017** at 6:00 p.m., at City Hall, 93 Washington Street in the second-floor Council Chambers. In attendance: Chairman Bob St. Pierre, member Paul Flores, Clerk of the Board, Melissa Pagliaro, Special Investigator, Sgt. Doyle. Absent was member Sarah Stanton.

1. Applications for a Street Performers License. Applicant: Richard Furr, Jr.

Mr. Furr presented the application and said he sings in his spare time and would like to perform downtown. Mr. Flores asked if he had read and signed the rules and regulations. Mr. Furr said he had and would really just like to come down on Sunday afternoons. He said he has a small amplifier and is aware of the decibel levels and has a decibel reader. Mr. Flores motioned to approve. Chairman St. Pierre seconded. Motion carries.

2. Application for a One Day Liquor License. Applicant: Jeff Casiglia for Hamilton Hall.

Mr. Casiglia said that this is for the 2nd Annual Burns Night Event at Hamilton Hall for 120 people on January 27, 2018 from 4-9pm. Mr. Flores asked if they were all set with the police detail. Mr. Casiglia said they are. Mr. Flores motioned to approve. Chairman St. Pierre seconded. Motion carries.

3. Application for three (3) One Day Liquor License. Applicant: Chris Weis from Bridge @ 211.

Ms. Weis presented the applications and said that she is on the Board of Trustees. She said they are asking to hold three paint and sip night events on 1/12/18, 3/9/18 and 5/11/18. She said they will all be held at 211 Bridge Street from 7-9:30pm for 30 people. Mr., Flores motioned to approve and waive the fees. Chairman St. Pierre seconded. Motion carries.

4. Application for a One Day Liquor License. Applicant: Marilyn Costa from St. Paul Shrine.

Ms. Costa said the event will be held at the St. James hall on Federal Street for a NYE Dinner Dance on 12/31/17 from 7pm-2am for 100 people. Mr. Flores asked if the police detail was all set. Ms. Costa said that it was and all other required paperwork was submitted. Chairman St. Pierre asked if there was going to be a band. Ms. Costa said they are having a DJ. Mr. Flores motioned to approve and waive the fee. Chairman St. Pierre seconded. Motion carries.

5. Application for a Common Victuallers License. Applicant: Caramel Bakery, 281 Essex Street.

Sophie Vallier, owner, presented the application. She said her and her father run the bakery and although she has been there for a while she did not realize she needed a license for the

few seats she has. She said the bakery consists of bakery and pastries and coffees. Ms. Pagliaro said that all of her paperwork is in order. Mr. Flores motioned to approve. Chairman St. Pierre seconded. Motion carries.

6. Old/New Business:

Sgt. Doyle said that there is a video that was sent to him regarding an incident at Village Tavern regarding their security staff and he would like to have them called before the Board sometime in the near future for a discussion. Mr. Flores and Chairman St. Pierre agreed to call them in for a discussion at the next meeting after the new year.
