**MINUTES OF THE SALEM LICENSING BOARD
OCTOBER 15, 2019**

On October 15, 2019 at 6:00 p.m. the Salem Licensing Board held a meeting at 98 Washington Street, Salem, MA. In attendance were Chairman Robert St. Pierre, Member Deborah Greel. City Solicitor Elizabeth Rennard and Acting Clerk Joanne M. Roomey. Absent were the Clerk of the Board Melissa Pagliaro and Member Paul Flores.

1. Applications for various Street Performer licenses: Kevin O'Neil, Shaun Hall, Dana Sheridan, Sierra Little, Charles Espinal, Ryan Costa, Honore Hokjzimana, Justra Gomez, Jon Doucette, Chris Dowgin, Cassandra Michael, Brian Fanning, Jesse Ciarmataro, Nicole Brien, Paul Gangi, Serenity Gangi, Logen Brien, Sophia Dell'Ali, Ariana Dell'Ali, Madison Donahue, Maggie Gilpatrick, Kim Hackett, John Hackett and Don Little.

All were approved and reminded of the rules and regulations that they signed off on. Ms. Greel motioned to approve. Mr. St. Pierre seconded. Motion carries.

2. Applications for One Liquor License at Salem Art Gallery, 64 Bridge Street from 9:00 p.m. to 12:00 p.m. for a Halloween Soiree on October 31, 2019 for 49 people.
