### **LICENSING BOARD MEETING MINUTES**

A meeting of the Salem Licensing Board was held on Monday, April 26, 2021 at 6:00 p.m., via ZOOM, an online video conference call system. Present on call were: Chairman Gary Barrett, members Deb Greel and Gary Santo, Jr. and Clerk of the Board, Melissa Pagliaro. Absent was Special Investigator to the Board, Sgt. John Doyle.

1. Application for an Entertainment License at 76 Wharf Street. Applicant: Mark Feeley d/b/a Ocean's Edge, 76 Wharf Street.  
  
Ms. Pagliaro presented the application as the applicant's or attorney were having technical difficulties. Request include Inside piped in music through speakers, 5 TV's, upstairs acoustic and light jazz, lower-level dining room and outdoor covered patio acoustic jazz, Sunday 11am-3pm, Monday through Thursday 5-10pm, Friday and Saturdays 5-11pm, not to exceed decibel limit of 73 measured 15 feet from the property line. Mr. Barrett said he would accept a motion to approve the application long as all distancing guidelines and decibel levels were adhered to. Ms. Greel seconded. Mr. Santo seconded. Mr. Barrett said the motion carries. Vote was confirmed by a roll call vote, 3-0.
2. Application for a One Day Liquor License for a wedding reception at the House of Seven Gables on September 5, 2021 Derby Street for 50 people from 2:30 - 8:00 p.m. Applicant: Superior Servers.  
  
Michelle McKenzie presented the application. She said the event would be on the stated date for 50 people and they would be providing table service. Ms. Pagliaro said all of the paperwork and insurance is in order. Ms. Greel motioned to approve. Mr. Santo seconded. Mr. Barrett said the motion carries. Vote was confirmed by a roll call vote, 3-0.
3. New Business/Old Business: Ms. Pagliaro said that a discussion regarding Street Performers would be happening soon.
4. Adjournment at 6:12 pm. Mr. Santo motioned to adjourn. Ms. Greel seconded. Mr. Barrett said the motion carries.
