As we continue our efforts to help Salem residents go "car-free," one of the major initiatives underway is the launch of a new on-demand City shuttle service. Thanks to a major Mass DOT grant that the City just received, that program is even closer to becoming reality. Read more about the grant award and the shuttle program in the newsletter.

The City of Salem also recently partnered with the City of Beverly to receive a regional climate change planning grant

from the Commonwealth. These funds will be used to develop an action plan articulating specific steps both of our coastal communities can take to prepare for the consequences of global climate change.

Salem is one of just thirteen communities across the nation that has been invited to participate in Smart Growth America's Opportunity Zones (OZ) Marketplace, an online tool for sharing information and opportunities in Salem's OZs. The 23rd SalemRecycles Book Swap is coming up next month. Find out more details about this event in the newsletter. SalemRecycles' book swaps have diverted around 200 tons of trash from our community's waste stream, saving Salem taxpayers around \$15,000 in disposal costs.

Shuttle Grant

The City of Salem has received a \$250,000 Workforce Transportation Program grant from the Massachusetts Department of Transportation. This funding will be used to help launch the City's forthcoming on-demand ride share shuttle service.

The concept for a shuttle service grew out of a feasibility study that began in 2017 through a partnership between Salem for All Ages, the City's Department of Traffic and Parking and other stakeholders including Salem State University, North Shore

Medical Center, and the North Shore Transportation Management Association. The goal of the study was to identify and implement an affordable and accessible public transit system that could encourage Salem residents to choose a "car-free" or "car-light" lifestyle to help reduce congestion and parking strains. After the in-depth feasibility study was completed, the City issued a Request for Proposals seeking bids from prospective shuttle vendors. The response period closed on January 17, 2020 and the City is now reviewing the proposals, with the goal of selecting a preferred vendor by the end of February, so service can begin in the Spring of 2020.

The funding from the Workforce Transportation Program grant will be combined with dollars donated to the City through its Host Community Agreements with cannabis retailers, as well as its development agreements with new housing developments that are under construction. The goal in combining these multiple funding sources is to keep the shuttle service as low-fare as possible for riders.

"I am grateful to the Baker Administration and our legislators for making this funding available, as well as to our City staff who worked so hard on this grant application," said Mayor Kim Driscoll. "This funding will help make possible a shuttle service that, we hope, will help reduce traffic on our streets, saving residents money and aggravation, while also helping us meet our climate goals."

Book Swap

On Saturday, March 14th SalemRecycles will host their 23rd Book Swap from 10am to 1pm at the Mayor Jean Levesque Community Life Center at 401 Bridge Street. Come on by and pick up some books or drop off books that you don't need anymore.

Please bring books, CDs & DVDs, Video Games, Records, Re-usable Bags, and Greeting Cards. All items must be clean and mildew free.

Please do not bring encyclopedias, magazines, textbooks over 10 years old, VHS tapes, and audio cassette tapes. Please no book dealers or more than two bags per swapper before noon. If you have lots of books, you may drop them off at the CLC before the event during the times below. Volunteers will be available to help carry and unload items. Please, no drop offs outside of Friday, March 13th, 4pm-7pm or Saturday, March 14th, 9am-noon. 

The Marketplace is a transparent, national hub where social impact investors from across the country can look for potential projects. Through the Marketplace, they can partner with cities to invest in equitable development in ways that help communities meet their goals for affordable housing, economic development, and more.

This new Marketplace is one part of Smart Growth America's National Opportunity Zones Academy, an 18-month technical assistance and peer learning effort that helps cities and towns create place-based, community-led approaches to sustainable growth and develop strategies to transform selected Opportunity Zones into economically-thriving and socially-inclusive places.

Schools Update

Superintendent Selection

Salem Public Schools is excited to announce the unanimous selection of Dr. Stephen Zrike to be offered the position of Superintendent for Salem Public Schools. The School Committee voted unanimously on February 13th to extend an offer to Dr. Zrike to enter into the next steps in the process to enter into contractual talks.

Dr. Zrike would come to Salem from Holyoke Public Schools where he currently serves as Receiver/Superintendent. He previously served as the Superintendent of Schools in Wakefield, Massachusetts and Chief of Elementary Schools for the Pilsen-Little Village Network in the Chicago Public Schools. He was responsible for leading the instructional improvement efforts for 26 schools and approximately 18,000 students.



In addition to his experience in Chicago, Dr. Zrike also served the Boston Public Schools as the turnaround principal of the William Blackstone Elementary School, an inquiry facilitator and leadership coach for four Boston schools, and as principal of both the William Ohrenberger Elementary School and John Philbrick Elementary School. Dr. Zrike's teaching career began in Massachusetts' Andover Public School District, as a fifth-grade teacher. He received his doctorate from the Urban Superintendents' Program and his Master's Degrees in Education from the Harvard Graduate School of Education. Dr. Zrike also holds a bachelor's degree in history from Dartmouth College.
