Ladies and Gentlemen of the City Council:

Enclosed is an Order seeking Council approval to implement our annual parking ticket amnesty program to waive up to \$30 in late fees on parking violations collected from December 1 through December 23, 2020 in exchange for a donation of canned goods and non-perishable items. All food will go to local Salem food pantries.

The "Peas for Fees" program has become an annual tradition in Salem and has proved to be successful bringing in donations of food for those in need and also additional receipts for the City. In the spirit of the holidays, this amnesty program will once again give individuals who owe late fees an incentive to pay their tickets, providing additional food supplies to very needy food pantries and hopefully resulting in an extra infusion of funds for the City.

This has been a practice that has been used in Massachusetts and other communities across the country as a way to provide residents and others with a benefit that relieves late penalties. While the City benefits from recovering unpaid ticket revenues, the added advantage to this initiative is the receipt of the canned goods, which are donated to local food pantries during the holiday season. This year we will have a receptacle located in the outer area of the Collector's Office, so staff will not need to handle the donated items.



All employees who work at least (6) hours per day shall be granted a meal period of thirty (30) minutes during each work shift. Whenever possible the meal period shall be scheduled at the middle of the shift.

ARTICLE XIII: SICK LEAVE

- A. Sick leave shall be granted for personal sickness and for up to five days for sickness or injury in the immediate family. Immediate family is defined as set forth in Part One, Section A of Article XV11, entitled Funeral Leave. As such, Immediate family shall mean: Spouse, Mother, Father, Brother, Sister, Children, Grandparents, Grandchildren, Mother or Father-inlaw, or any other dependent living in the household.
- B. For absence due to illness in excess of (5) consecutive working days the Employer may require, for purposes of additional evidence, a certificate from a physician.
- C. The parties recognize and agree to adhere to the Absence Control Policy as adopted by the City, excepting for the requirement of a certificate from a physician, which is governed by paragraph B above.
- D. Employees absent because of an industrial accident may, if they so desire, draw from their sick leave credits, to make up the difference between the payment of compensation and their full week's pay.
- E.1 On retirement or death of and employee who was employed on or before July 1, 2000 payment for accumulated unused sick leave will be made to the employee or his/her estate, up to a maximum of ninety (90) days.
- E.2 On retirement or death of an employee who was employed on or are July 1, 2000 through June 30, 2002, payment for accumulated unused sick leave will be made to the employee or his/her estate, up to a maximum of forty-five (45) days.
- E.3 Effective upon the execution of the 2011-2014 Agreement the District agrees to offer the following two options regarding Sick Leave Buyback to members on a voluntary basis.

Option A - Members with a Service Date of 1/1/2003 or earlier.

Upon written request by the member, the District agrees to provide the member with a one-time payment for fifty percent of the member's accrued sick leave, at the rate of one hundred twenty-five dollars (\$125.00) per day. The maximum number of days a member may receive payment for cannot exceed forty-five (45) days. Upon retirement from the District, any member who has received payment from the District in accordance with this Section will have his or her sick leave buyback in accordance with Section F, paragraphs 1 & 2 reduced by the number of days he or she has received hereunder. The member has the option to request the District deposit this one-time payment in the member's preferred deferred compensation plan.

All employees who work at least (6) hours per day shall be granted a meal period of thirty (30) minutes during each work shift. Whenever possible the meal period shall be scheduled at the middle of the shift.

ARTICLE XIII: SICK LEAVE

- A. Sick leave shall be granted for personal sickness and for up to five days for sickness or injury in the immediate family. Immediate family is defined as set forth in Part One, Section A of Article XV11, entitled Funeral Leave. As such, Immediate family shall mean: Spouse, Mother, Father, Brother, Sister, Children, Grandparents, Grandchildren, Mother or Father-in-law, or any other dependent living in the household.
- B. For absence due to illness in excess of (5) consecutive working days the Employer may require, for purposes of additional evidence, a certificate from a physician.
- C. The parties recognize and agree to adhere to the Absence Control Policy as adopted by the City, excepting for the requirement of a certificate from a physician, which is governed by paragraph B above.
- D. Employees absent because of an industrial accident may, if they so desire, draw from their sick leave credits, to make up the difference between the payment of compensation and their full week's pay.
- E.1 On retirement or death of and employee who was employed on or before July 1, 2000 payment for accumulated unused sick leave will be made to the employee or his/her estate, up to a maximum of ninety (90) days.
- E.2 On retirement or death of an employee who was employed on or after July 1, 2000 through June 30, 2002, payment for accumulated unused sick leave will be made to the employee or his/her estate, up to a maximum of forty-five (45) days.
- E.3 Effective upon the execution of the 2011-2014 Agreement the District agrees to offer the following two options regarding Sick Leave Buyback to members on a voluntary basis.

Option A - Members with a Service Date of 1/1/2003 or earlier.

Upon written request by the member, the District agrees to provide the member with a one-time payment for fifty percent of the member's accrued sick leave, at the rate of one hundred twenty-five dollars (\$125.00) per day. The maximum number of days a member may receive payment for cannot exceed forty-five (45) days. Upon retirement from the District, any member who has received payment from the District in accordance with this Section will have his or her sick leave buyback in accordance with Section F, paragraphs 1 & 2 reduced by the number of days he or she has received hereunder. The member has the option to request the District deposit this one-time payment in the member's preferred deferred compensation plan.

All employees who work at least (6) hours per day shall be granted a meal period of thirty (30) minutes during each work shift. Whenever possible the meal period shall be scheduled at the middle of the shift.

ARTICLE XIII: SICK LEAVE

- A. Sick leave shall be granted for personal sickness and for up to five days for sickness or injury in the immediate family. Immediate family is defined as set forth in Part One, Section A of Article XVII, entitled Funeral Leave. As such, Immediate family shall mean: Spouse, Mother, Father, Brother, Sister, Children, Grandparents, Grandchildren, Mother or Father-inlaw, or any other dependent living in the household.
- B. For absence due to illness in excess of (5) consecutive working days the Employer may require, for purposes of additional evidence, a certificate from a physician.
- C. The parties recognize and agree to adhere to the Absence Control Policy as adopted by the City, excepting for the requirement of a certificate from a physician, which is governed by paragraph B above.
- D. Employees absent because of an industrial accident may, if they so desire, draw from their sick leave credits, to make up the difference between the payment of compensation and their full week's pay.
- E.1 On retirement or death of and employee who was employed on or before July 1, 2000 payment for accumulated unused sick leave will be made to the employee or his/her estate, up to a maximum of ninety (90) days.
- E.2 On retirement or death of an employee who was employed on or after July 1, 2000 through June 30, 2002, payment for accumulated unused sick leave will be made to the employee or his/her estate, up to a maximum of forty-five (45) days.
- E.3 Effective upon the execution of the 2011-2014 Agreement the District agrees to offer the following two options regarding Sick Leave Buyback to members on a voluntary basis.

Option A - Members with a Service Date of 1/1/2003 or earlier.

Upon written request by the member, the District agrees to provide the member with a one-time payment for fifty percent of the member's accrued sick leave, at the rate of one hundred twenty-five dollars (\$125.00) per day. The maximum number of days a member may receive payment for cannot exceed forty-five (45) days. Upon retirement from the District, any member who has received payment from the District in accordance with this Section will have his or her sick leave buyback in accordance with Section F, paragraphs 1 & 2 reduced by the number of days he or she has received hereunder. The member has the option to request the District deposit this one-time payment in the member's preferred deferred compensation plan.

As you know, SiFi is in the process of installing a City-wide high-speed fiber internet network in the City of Salem. While the project was slightly delayed due to the pandemic, they are still moving forward. The Mayor is hereby authorized to execute, on behalf of the City of Salem, an amendment to the July 24, 2018 Fiber Optic Network Installation Agreement between the City and SiFi Networks Salem, LLC to allow a change in Section 3.5.8, "Security Deposit" such that SiFi Networks Salem shall have the option of providing either a \$500,000 performance bond or a cash security deposit in the same amount to be held in escrow by the City Treasurer.

minimum coverages required by this Agreement, which shall be maintained on file in the City's Engineering Department. Coverages shall not be reduced, canceled, non-renewed or materially changed without thirty (30) days advance written notice to the City.

- 3.5.7 No Waiver. Receipt or review by the City of any copies of insurance policies, endorsements or certificates that fail to comply with the requirements of this Agreement, or the City's failure to request or obtain evidence of insurance or to object to the insurance provided, shall not be deemed a waiver of any requirements contained in this Agreement and shall not relieve SiFi Networks Salem of its duty to comply with the requirements contained in this Agreement.
- 3.5.8 Security Deposit. Prior to installing its first fiber optic network facility under this Agreement, SiFi Networks Salem will deliver to the City a valid performance bond in the sum of five hundred thousand dollars (\$500,000), issued by a surety company acceptable to the City's Controller in a form acceptable to both Parties. SiFi Networks Salem agrees and acknowledges that such bond will allow for the use of the bond to cover incidental expenses and costs, damages and fees not covered by any insurance policies, including but not limited to: interest, charges by the City to remove fiber optic network facility from City-owned infrastructure and, to the extent practical, restore such sites to their prior condition, reasonable wear and tear excepted, pursuant to this Agreement, and any unpaid permit and administrative fees. SiFi Networks Salem shall keep such performance bond, at its expense, in full force and effect until the one hundred eightieth (180th) Day after the Expiration Date or other termination of this Agreement, to insure the faithful performance by SiFi Networks Salem of all of the covenants, terms and conditions of this Agreement. Such bond shall provide for thirty (30) Days prior written notice to the City of cancellation or material change thereof. If the bond is cancelled or not extended, SiFi Networks Salem shall replace it with another at least ten (10) Days prior to expiration and if SiFi Networks Salem fails to do so the City shall be entitled to present its written demand for payment of the entire face amount of such bond and to hold the funds so obtained as a security deposit. Any unused portion of any such Security Deposit shall be returned to SiFi Networks Salem upon replacement of the bond or deposit of cash security in the full amount required.

4. Parties' Obligations.

AMENDMENT NO. 3 TO FIBER OPTIC NETWORK INSTALLATION AGREEMENT BETWEEN SIFI NETWORKS SALEM LLC AND CITY OF SALEM, MA

This Amendment No. 3 ("Amendment. No. 3") to the Fiber Optic Network Installation Agreement effective November ___, 2020 ("Amendment Effective Date") are between SiFi Networks Salem LLC ("SiFi") and City of Salem, a political subdivision of the Commonwealth of Massachusetts (the "City"). Capitalized terms used but not defined herein shall have the meaning given such terms in the Fiber Optic Network Installation Agreement.

1. Background

- A. SiFi and City entered into that certain Fiber Optic Network Installation Agreement on 24th of July 2018 and Amendment No. 1 dated September 2, 2020 and Amendment No. 2 dated September 15, 2020 (collectively, the "Agreement").
- B. Pursuant to Section 3.5.8, Security Deposit, of the Agreement, SiFi is required to provide a certain security deposit or bond, however, the parties agree to clarify the language in said Section and wish to modify said Section accordingly.
- C. SiFi and City now wish to, accordingly, amend the Agreement on the terms and conditions herein.

2. Amendment

As of the Amendment Effective Date, SiFi and the City hereby agree to amend the Agreement by deleting Section 3.5.8, Security Deposit, in its entirety and replacing it with the following:

Subsequent to the pilot construction and prior to commencing installation of its next fiber optic network facility under this Agreement, SiFi Networks Salem will deliver to the City a valid performance security ("Performance Security") in the aggregate sum of five hundred thousand dollars (\$500,000) ("Security Amount") to insure the faithful performance by SiFi Networks Salem of all of the covenants, terms and conditions of this Agreement. Such Security Amount shall be provided, in each case as and when applicable and further described below, (i) in the form of an annually renewable performance bond ("Bond") issued by a surety company reasonably acceptable to the City's Finance Director in a form acceptable to both Parties or (ii) in the form of a cash security deposit ("Cash Security Deposit") to be held in escrow by the City Treasurer and subject to the terms and conditions of this Section 3.5.8 including but not limited to drawing on and release of any Cash Security Deposit. SiFi Networks Salem agrees and acknowledges that such Performance Security will cover incidental and direct expenses and costs, damages and fees incurred by the City and not covered by any insurance policies to the extent arising out of SiFi Networks Salem's uncured breaches of this Agreement subject to Section 6.1, including but not limited to: interest, charges incurred by the City for the removal, to the extent required under the Agreement, by the City of the applicable fiber optic network facility from City-owned infrastructure, including the section of the network installed during the pilot and, to the extent practical, restore such sites to their prior to the inception of the

Agreement condition, reasonable wear and tear excepted, pursuant to this Agreement, and any unpaid permit and administrative fees.

If the Performance Security is in the form of a Bond and such Bond is cancelled or not extended or not renewed to the extent Performance Security is still required, SiFi Networks Salem, at its sole discretion, with prior written notice to the City, shall replace it with another substantially similar Bond or a Cash Security Deposit, in either case ("Replacement Performance Security"), in an amount ("Replacement Security Amount") equal to the difference between (x) the Security Amount and (y) the amount of any claims made and paid against the Bond, required under this Section 3.5.8. SiFi Networks Salem may also, in its sole discretion, at any time replace a Cash Security Deposit with a Bond, in amount equal to the difference between the (x) Replacement Security Amount and (y) the amount of any claims charged against the Replacement Performance Security of such Security Deposit and any unused portion of any such Cash Security Deposit shall be returned to SiFi Networks Salem upon replacement with a Replacement Security Bond.

All Bonds shall provide for thirty (30) days prior written notice to the City of cancellation, nonrenewal, or material change thereof. If a Bond is cancelled or not extended, SiFi Networks Salem shall replace it with another at least ten (10) days prior to expiration unless it chooses to replace it with a Cash Security Deposit in which case SiFi Networks Salem shall give the City at least ten (10) days prior written notice of its intent to do so. If SiFi Networks Salem chooses to replace a Cash Security Deposit with a Bond, it shall also provide the City with at least ten (10) days prior written notice.

SiFi Networks Salem shall, without any gaps of coverage to the extent Performance Security is still required, at its costs and expense, keep such Performance Security or Replacement Performance Security, as the case may be, in place until the earlier date of (i) when the Security Amount is fully depleted as provided for in this Section 3.5.8, or (ii) until expiration or termination of this Agreement. In any case, City shall have twelve (12) months from the date the covered claim occurred to either make a claim with the surety issuing the Bond or to charge against the Cash Security Deposit, as the case may be and in either case by providing written notice to SiFi Networks Salem. Failure by SiFi Networks Salem to comply with the requirement to keep-either-a Performance Security or a Replacement Performance Security in place without any gaps in coverage in accordance with the terms set forth above will be a material breach of this Agreement, and will not be covered by the cure provisions of Section 6.1.1. SiFi Networks Salem will have a period not to exceed thirty (30) days from a City Breach Notice to cure any gap in coverage.

General

Other than as set forth herein above, the Agreement remain unchanged and in full force and effect. If there is a conflict between the terms of the Agreement and this Amendment No. 3, this Amendment No. 3 will control.

Ladies and Gentlemen of the City Council:

Enclosed please find a bond Order authorizing up to \$16.1 million in borrowing in order to carry out the City's Signature Parks Initiative over the next six years. Accompanying the Order and this letter you will also find an FAQ, a copy of a presentation summarizing the initiative, and the bond schedule. As you know, a bond authorization allows the City to incur future debt to carry out these projects, however the full \$16.1 million is not borrowed all at once, but is instead spread out over years as needed to implement the work on the planned schedule.

As has been discussed for the last few years, the Signature Parks Initiative is a key component of our community's quadricentennial planning, for when Salem turns 400 years old in 2026. This initiative is focused on planning and carrying out improvements and preservation work in six of Salem's busies and most beloved public parks and open spaces, ensuring they will remain available and enjoyable for future generations to come: Forest River Park, Palmer Cove Park, Pioneer Village, Salem Common, Salem Willows, and Winter Island.

The work to plan for these improvements has been carried out, in most cases, over the last several years through extensive engagement with neighbors, park users, and other stakeholders. These signature spaces serve the neighborhoods in which they are located, but also the entire Salem community and beyond, providing recreational, cultural, and aesthetic value to the City. In many respects, these spaces show their age and how well-loved they have been by generations of Salem residents. The Salem Signature Parks Initiative will implement the designed improvements, preserve historic features, upgrade spaces to address climate change, and expand access and creative use of the parks. The planning for each space also provides for sustainable revenues, to provide for the on-going maintenance and care of the spaces after the projects are complete.

While the bond authorization is \$16.1 million, the full cost of these projects is estimated to be closer to \$30.43 million. The remainder of the funds needed to carry out the work, \$14.33

million in all, consists of existing funds (\$6.68 million) and future anticipated grants, donations, and one-time revenue sources (\$7.65 million).

We are not only advancing this request now because 2026 is rapidly approaching, but also because we currently can borrow at a historically low interest rate, most likely under 2.0%. That interest rate, combined with our historically strong bond rating, means we now could fund these projects at a considerable savings. Deferring this authorization to a future year would be financially irresponsible, as it would mean borrowing when interest rates will almost certainly be much higher and additionally result in an increase in the cost of construction, which escalates over time.

Financially, we believe Salem is strongly situated to take on this debt, which will be spread out over the next several years as the funding is needed for each project. In their most recent ratings report, Standard and Poor's specifically lauded the City's debt liability and "low overall net debt" levels. This is a continuation of our fiscally responsible practices and policies that have, since 2006, resulted in the share of our City budget that is our annual debt payment being reduced by a third. Enclosed in this package you will find the bond schedule for this authorization, as well as a listing of the City's existing debt and when it will be coming off the books, to illustrate our debt capacity level and how this authorization is compatible with our long-range capital plans.

Because the City Council only has one further meeting in 2020 and bond Orders require two passages, we are asking that the Council consider granting first passage at this evening's meeting as a provisional matter only, to allow for the possibility that second passage could take place at your only meeting in December. We recommend that, after first passage, the matter be referred to the Committee on Administration and Finance, for a meeting on the request to take place between now and your December 3rd regular City Council meeting.

Ordered: That the sum of Sixteen Million One Hundred Thousand Dollars (\$16,100,000) is hereby appropriated to pay costs of a signature parks improvement program that includes one or more of the following types of capital improvements at Forest River Park, Salem Willows, Salem Common, Pioneer Village, Winter Island, and Palmer Cove and any costs incidental and related thereto: (a) construction, reconstruction and/or relocation of, and extraordinary repairs and improvements to, buildings, structures, recreational facilities and landscape infrastructure, (b) construction and reconstruction of, and improvements to, roadways, sidewalks and pathways, and (c) acquisition and installation of lighting, fencing, benches, signage and other equipment; that to meet this appropriation, the Treasurer, with the approval of the Mayor, is authorized to borrow said amount under and pursuant to Chapter 44, Section 7(1) of the General Laws, or pursuant to any other enabling authority, and to issue bonds or notes of the City therefor; that the Mayor is authorized to apply for, accept and expend any grants, donations or other aid to pay additional costs of the signature parks improvement program; that the Mayor is authorized to take any action necessary to carry out the signature parks improvement program; and that any premium received by the City upon the sale of any bonds or notes approved by this order, less any such premium applied to the payment of the costs of issuance of such bonds or notes, may be applied to the payment of costs approved by this order in accordance with Chapter 44, Section 20 of the General Laws, thereby reducing the amount authorized to be borrowed to pay such costs by a like amount.

Projects

Why are we doing these projects now?

These are all necessary improvements to existing facilities that are identified in larger capital plans or studies. Each of these facilities needs capital investment to ensure its use and enjoyment over the next few decades. Over the years, our parks have seen increased use and, as a result, increased needs. These parks are much loved but need important upgrades to ensure they are around for future generations to enjoy. Authorizing these funds will allow the six signature parks projects to advance on a timetable that will enable them to be completed by 2026, Salem's 400th anniversary. Interest rates are at historic lows and the City's bond rating is at its strongest, meaning these funds can be borrowed now at far less cost than they may be in the future, especially as deferred construction costs will only increase with time.

 Are we only doing these because the City hasn't invested in maintenance of these parks?

No, all these parks have enjoyed both regular maintenance and smaller capital investments in the past. These projects are not a replacement for those routine more routine efforts but are rather instead major upgrades intended to address larger needs including accessibility, climate change resiliency, historic preservation, and other major improvements that will extend their lifespans substantially. In this case, these are large capital investments needed because the park infrastructure is beyond its useful life or close to it, regardless of the level of past maintenance. All of the projects are designed to support ongoing maintenance in the future, to ensure these improvements are able to be enjoyed by Salem residents for decades to come.

Are the improvements for these parks already designed? Who decided what went into them?

In some of these cases, the projects have been designed over the past few years through public, transparent processes that involved stakeholder groups that consisted of park users, City officials, neighborhood associations, and others. In the typical process, design concepts were developed through a public input and engagement process that relied on those community stakeholders to provide feedback to a project consultant. The designed plans are then turned into engineering and construction drawings, which are then subsequently bid for construction, based on the availability of funding, which this effort would provide. Each project is in various phases of this process.

- Forest River Park is designed and in final construction document stage.
- The larger project at Willows is in final design stage, but other smaller improvements, such as additional paths, building improvements, etc. have just been identified but not prioritized or designed.
- On the Common, the bandstand and fence components of the project are designed and only need final design and construction documents. Other improvements that are considered such as walkways, landscaping, curb cuts, playground work, and others have been identified, but not designed.

- For Pioneer Village/Camp Naumkeag, a feasibility study has been completed and the initial study/design started this Fall.
- The Palmer Cove Park design process is completed, and construction of Phase 1 is close to ready to commence.
- With Winter Island, studies have identified potential improvements, but no design has started.

When will the projects be completed?

- Forest River Park Summer 2021
- Willows Hill area, parking, and tennis courts Summer 2021 (some plantings will require another season). Other improvements (accessible upgrades to buildings, tree plantings, path restoration, other improvements) will be ongoing through 2025.
- Palmer Cove Phase 1 (community gardens, harbor walk, basketball court) in 2022, Phase 2 (placemaking) in 2023, and Phase 3 (athletics fields, walkways and entry points) in 2025.
- Common Bandstand Phase 2 restoration including windows, masonry, electrical, etc. - Spring 2022. Next phase of fence – 2024-2025. Other landscape and hardscape improvements – ongoing through 2025.
- Pioneer Village Site layout and plantings and moving or rebuilding existing Pioneer Village structures - Summer 2022. Phase 2: New Visitor Center - Spring 2026.
- Winter Island Start work in 2022 and finish work by Summer 2026. The
 phasing would depend upon the priority of elements within the overall project.
- Will these projects include accessibility upgrades? Climate change resiliency? Yes, each project was intentionally designed to address accessibility problems at the parks, many of which were identified through the City's ADA Transition Plan, but others that were found before that plan was conducted. They also include climate resiliency and flood inundation measures, which are essential and required as many of these projects are coastal or close to the shore.
- Do the projects include plans for ongoing maintenance and operations? Yes, the project plans include opportunities for sustainable revenue generation that can be used to provide ongoing funding for maintenance and operations. In addition, with the completion of each project, the City's Capital Projects team will ensure a maintenance plan and schedule is provided to the responsible department, incorporated into the City's capital assets management system, and accounted for in future budgets.

Financing

• How much does this add to our City's debt? Do we have existing debt coming off the books?

This bond authorization is for \$16.1 million over 28 years. Since this initiative is a multiyear project, the \$16.1 million will not be borrowed at the outset of the authorization, but in increments over six years. The total debt with interest, is projected to be approximately \$25.4 million through FY2056. This borrowing will add approximately \$900,000 per year to the annual debt payment schedule, but the existing annual debt payments will decrease by approximately \$2.4 million by the end of FY2027.

How much will those debt payments increase my tax bill?

It's impossible to estimate precisely how this debt will impact individual taxpayers for a few reasons. First, it's possible that the park-generated revenues will also help offset the bond costs to some extent. In those cases, users will help fund some of the debt, reducing the burden on taxpayers. Second, because taxes reflect home values as well as the cost of government, and it's not possible to predict what future values may be, it's likewise not possible to estimate what a future tax bill might be. In all, Salem has reduced the total share of the City budget that is its annual debt payment by one-third since 2006, however.

- Are there any non-tax revenues that can be used to pay the debt? Yes, it's possible that park-generated revenues may be able to be used toward the debt payments for these bonds. Those revenues might include parking fees, pool memberships, room rentals, gift shop and ticket revenues, and more.
- Why not wait until the economy has improved and the City budget is in a better position before taking this on?

Salem has the best bond rating in its history now, and interest rates are at a near record low. Taken together, that means the City can borrow money now at possibly the lowest cost than it ever will again for quite some time. When that is combined with the fact that construction costs escalate over time and the City's annual debt payments of existing debt over the next six years will be reduced by \$2.4 million, it makes it apparent that now is an opportune and financially responsible time to take on this work.

What happens if costs increase and the bonds aren't enough to pay for the projects to be finished?

The intention for each project is to bring in additional funding through grants and even private donations to meet some of the anticipated costs. Most of the projects are designed to be scalable, so costs can be reduced by forgoing certain improvements if costs increase dramatically or if other revenue sources are not able to be secured. In addition, in the future, if the cost of any of project increases, future City Councils could act to increase the bond authorization.


