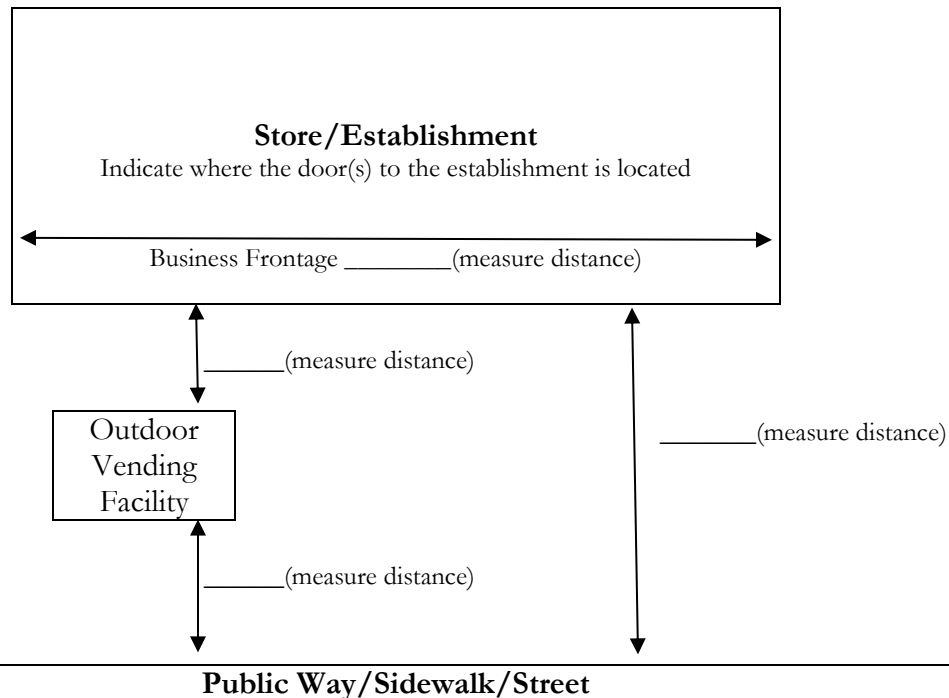

Instructions: Applicants must sketch in the proposed location of the outdoor vending facility as well as any poles, bollards, fire hydrants, trees, planters, or other features within the public or private right-of-way/sidewalk adjacent to the store/establishment.

The applicant shall provide exact measurements for distances between the proposed facility and the building and any other features (as listed herein) within the public or private right-of-way/sidewalk adjacent to the store/establishment.

Provide the following information/documents:

- ☐ Photographs of the building and sidewalk showing where the outdoor vending facility is proposed

In accordance with the Salem Building Department you must leave a 4-foot handicap access path in front of your business for wheelchairs to pass by unobstructed. If any city official asks you to move your setup you must comply.
