Meeting Minutes  
Tuesday, May 14, 2019

An Executive Session of the Salem School Committee was held on Tuesday, May 14, 2019 in the School Committee Chambers at Collins Middle School, 29 Highland Avenue, Salem, MA.

**Call to Order – Executive Session**

Mayor Kimberley Driscoll called the Executive Session meeting of the Salem School Committee to order, at 7:49pm, for the purpose of reviewing the Minutes for the Special School Committee meeting held April 15, 2019 and the Executive Session held April 25, 2019.

Mr. Fleming motioned to convene in Executive Session, under Exemption 7, to comply with MGL c.30A s.22 (g)(2) (Review of Special School Committee minutes from April 15, 2019 and Executive Session minutes from April 25, 2019 to determine whether the minutes or portions thereof can be released), and not to reconvene in Open Session. Ms. Manning seconded the motion.
